



Pre-Conference: Grapevine Board Report

- Distributed 110,549 Grapevine and LaVina books, ebooks, CDs and other items in 2019.
- Pursuing outside sales.
- \$1,893,500 balance in reserve fund, for unfulfilled subscriptions. Liability is \$1,665,502
- 125,000 people took advantage of the free online issues offer.
- GV app not working well, so now using ePublish format (for tablets and other devices)

Pre-Conference: Grapevine Board Report

- Daily Quote book was going to be commemorative item sold at International – redoing cover and will publish
- Educate fellowship GV is self supporting only through sales of their magazine and books
- YouTube channel 16 audio stories, 6 explainer videos (like how to be a GV rep). Over 600 new audio stories submitted for GV, over 170 for LV.



Pre-Conference: AAWS Board Report

- New Communications Services Department: handles websites, YouTube, Google for Nonprofits, LinkedIn and Meeting Guide App
- Normalized pricing of literature
- 93 GSO employees at end of 2019
- Updating "Safety and AA: Our Common Welfare" and safety card and creating new Safety and AA flyer, to be easily displayed
- Will have a strategic planning meeting virtually in June

Trustees' Report: Archives

- Future printings of the Archives workbook will avoid the use of gender specific language.
- There is a new Policy on Loans that will be included in future printings of the Archives Workbook



Trustees' Report: CPC/Treatment and Accessibilities

- General Service Board members are being encouraged to attend professional conferences with CPC exhibits if it's in their region or area of expertise.
- There is a "Phase 1" list of pamphlets that will be published without staples to help carry the message to settings where staples would prevent their entry.
- So far 2 audio interviews with military professionals are completed and they are working on another 2 and posting them online.
- In 2019, gave presentation at DOD Conference and were interviewed for a podcast posted on the Dept of Veteran's Services webpage

Trustees' Report: Corrections

- Broad request for shared experience about tools used for local databases on correctional facility meetings only got one response so they are sharing that template in the next printing of the workbook.
- A letter to parole and probation professionals was created to raise awareness about Prerelease and BTG. It will go in the workbook and may be mailed out from GSO.
- Will work with CPC to contact and approach training programs and conferences for corrections professionals.

Trustees' Report: Nominating

 Recommending to the General Service Board that the terms/rotation schedule of Class A trustees change so one rotates onto the board and another off each year, with the exception of the GSB chair.

Staff Report: AA Grapevine

 Started optimizing product metadata for better search and reader discovery by rewriting nearly all product descriptions (for books, magazines, calendars and other products), both on physical products and online.

 Began producing explainer videos and short videos using member's personal stories from the Grapevine Audio Project to

launch on Grapevine's YouTube channel.



Staff Report: Archives

 Conducted an inventory of our off-site collection of analog and digital recordings, both audio and video. They found one box of unprocessed audio recordings and identified 24 tapes of enduring value for audio preservation.



Staff Report: CPC/Treatment


 In 2019, coordinated 32 A.A. traveling exhibits at national professional conferences. In 2020, 35 exhibits are scheduled with a focus on professional groups related to ethnic diversity, professional diversity and geographic diversity that may refer A.A. to underrepresented communities



This past spring, Diana and one of A.A.'s nonalcoholic trustees, Leslie Backus (above), a health treatment provider and CEO at a rehab facility located in Savannah, Georgia, attended the American Society of Addiction Medicine (ASAM) gathering in Orlando, Florida. Over 2,300 attendees participated in this conference, and over 200 visitors stopped by the booth, asking questions and collecting information about A.A.

Staff Report: Corrections

- Approximately 600 pieces of mail arrive monthly from inmates, many requesting free literature, others asking to participate in our Corrections Correspondence Service or for help in making contact with A.A.
- In 2019 linked 1,474 male and 401 female alcoholics in prison to an outside A.A. correspondent through the C.C.S.



Staff Report: Public Information

 Read and review media stories that mention Alcoholics Anonymous and share relevant information as needed.

Staff Report: Staff Coordinator

• In 2019, the staff received 91,589 pieces of correspondence by mail, email and fax, and answered over 11,793 phone calls.


2019 Financial Results - What Happened?

- The 2019 GSO Budget showed a net profit of \$501,221 but the actual for 2019 is a loss of \$379,655
- Income was \$62,512 less than budgeted and expenses were \$943,388 more than budgeted
- Expenses for Contracted Services and Professional Fees were higher than expected
 - Professional Fees were \$317,653 over budget, in large part due to contract reviews. AAWS is in the process of implementing a new way to review contracts which is both cost efficient and less time consuming
 - Contracted Services were \$831,948 over budget, in large part due to the implementation of NetSuite, the new ERP System


7th Tradition

Distribution of Received Contributions




GROWTH OF ON-LINE CONTRIBUTIONS2010 – 2019






7TH TRADITION SELF-SUPPORT – 2005 – 2019



BIG BOOK – UNITS SOLD – 2000– 2019





GRAPEVINE - KEY AMOUNTS - 5 YEAR HISTORY


GROSS PROFIT & NET PROFIT





INVESTMENT GUIDELINES


"Minimum Requirement"

To assure the liquidity, the Reserve Fund shall contain investment instruments having maturities of one year or less in an amount equal to the sum of (a) the unearned Grapevine subscription liability and (b) the operating cash requirements of the service entities. This amount will be reviewed annually by the trustees' Finance and Budgetary Committee.

"No More Than"


The balance of the Reserve Fund shall be invested in instruments with maturities of between zero (0) and ten (10) years, provided that at no time shall more than 50% of the principal amount of such balance consist of investments having maturity dates of five or more years.

The General Service Board Reserve Fund

In 1954, the Board of Trustees established a Reserve Fund whose principal purpose is to provide the financial resources necessary to continue the essential services of G.S.O. and the Grapevine in the event of emergency or disaster, to fund costs beyond the means of the G.S.O. and the Grapevine, such as major leasehold improvements or technical upgrades, and to allow the General Service Board and its two operating affiliates time to formulate and implement plans needed to adjust to changed economic or other conditions.
